INSTRUCTIONS: ACR UPGRADE PROGRAM APPLICATION FOR RECORDING



The following breeds have been approved as Foundation animals: Romney, Border Leicester, Cotswold, English Leicester, Bluefaced Leicester and Lincoln. All animals in this Program must meet the standard for their particular breed and be registered with their officially recognized breed association. A copy of the original Registration Certificate of the Foundation animal must be attached to the ACR Application for Recording.

1. **Prefix & Private ID** – This is the combination of letters & numbers that identifies the animal you are using in this program. It corresponds to the animal’s ear tag or tattoo and links the animal and its registration paper. Limit 25 characters including spaces.
2. **Action** – Refer to the list of actions at the bottom of the Application. Circle the letter that corresponds to the action you are requesting for each animal.
3. **Color** – Use the Color Codes listed on the Application.
4. **Sex** – Use R for ram and E for ewe.
5. **Birth Date** – Give the month, day and year.
6. **Birth Type** – Circle one – S for single, Tw for twin or Tr for triplet. If the animal is from a larger litter, please write in the number born, e.g. a quadruplet would be indicated by “4”.
7. **Sire Information** – If the ram is registered or recorded with ACR, indicate his ACR#. If the ram is being entered as a Foundation animal, list its Prefix & Private ID as written on his Registration paper and attach the Registration to your Application.
 - **Percentage** – This relates to the percentage Coopworth blood of the ram. The percentage blood of a Foundation animal is always 0%. The percentage blood of an ACR Recorded or Registered ram is indicated on its ACR Certificate of Recording or Certificate of Registry.
8. **Dam Information** – If the ewe is registered or recorded with ACR, indicate her ACR#. If the ewe is being entered as a Foundation animal, list its Prefix & Private ID as written on her Registration paper and attach the Registration paper to your Application.
 - **Percentage** – This relates to the percentage Coopworth blood of the ewe. The percentage blood of a Foundation animal is always 0%. The percentage blood of an ACR Recorded or Registered ewe is indicated on its ACR Certificate of Recording or Certificate of Registry.

Transfer of Ownership – If you sell a Recorded animal, complete the Transfer of Ownership section on the back of the Certificate of Recording and send it to the Registrar with the required fee. It is your responsibility to **complete** the Transfer of Ownership when you sell an animal. Transfer is not complete until payment has been made.

Breeder & Owner – The “Owner” is the owner of the dam at the time of lambing. The “Breeder” is the owner of the dam at the time of mating. The Application must be signed by the Owner. If the Breeder is someone other than the Owner, a Breeder Declaration must be attached to the Application. The Breeder Declaration is available to download on the Forms page at the ACR website — www.americancoopworthregistry.org/forms.html

Artificial Insemination – A Certificate of AI Breeding must be attached to the Application for Recording if AI was used for Upgrading. The form is available to download on the Forms page at the ACR website — www.americancoopworthregistry.org/forms.html
